Lake Oswego, Oregon – Citizens in Lake Oswego will join thousands of individuals across the country to celebrate National Preservation Month this May with the State Historic Preservation Office and the National Trust for Historic Preservation. This is a month long opportunity to showcase the City’s historic places. Preservation month is meant to connect the preservation community and introduce new audiences to the City’s work in preservation of the places that make Lake Oswego special.

Here in Lake Oswego, Preservation Month, 2017 will be observed by:

- A [Historic Preservation Proclamation](#) issued by Mayor, Kent Studebaker at the City Council meeting on **May 2**.
- A preservation workshop “[Your House Matters](#)” at the Lake Oswego Heritage House and Museum on **May 7**.
- Presentation of three Merit Awards to Safeway Corp., the Oswego Heritage Council and Lake Oswego Preservation Society for historic preservation by a member of the Historic Resources Advisory Board.
- An exhibit highlighting Lake Oswego’s Iron Industry will be featured in the City Hall lobby and other public venues.
